Structure	Charge	Membership
Council	Coordinate Board connections to and liaisons with the committees, special interests groups, and task forces	Board members acting as a liaison within a Council and serving in an advisory ex-officio role
Liaison	Advisory role to support, connect and guide the committees, special interest groups and task forces	Board members serving in an advisory ex-officio role
Committee	Ongoing activities driven by the strategic plan and direction from the Board	A limited number of rotating members selected to serve for limited terms (e.g., 3 years)
Special Interest Groups (SIGs)	Ongoing activities driven by the grassroots (i.e., the interests of SIG members)	Unlimited membership without term restrictions
Task Forces	Time-limited activity identified by the Board, potentially in response to Committee and/or SIG activities	A limited number of members serving for only the length of the Task Force charge
Judging Panel	Select award winners	Depends on the specific award
